1. Introduction

In 2018, the Effective Institutions Platform (EIP) embarked on a revisioning exercise to ascertain its value add, sharpen its focus, and renew its membership and governance arrangements. This process culminated in an Annual Meeting that took place in Paris on 25 and 26 April 2019.

During the meeting it was agreed that the EIP Secretariat would map existing P2P initiatives to get a sense of who is doing what, and to identify opportunities for the EIP to broaden its membership and establish strategic partnerships.

Strategic partnerships and revamped membership are key parts of positioning the EIP as a global knowledge hub on peer-to-peer learning and a platform that facilitates the incubation of, and learning from, alternative and innovative approaches to institutional development.

The Secretariat conducted a survey and identified initiatives with an active online presence using Peer-to-Peer methodologies or providing resources for reform practitioners. The results are reflected in this mapping. The Secretariat considers this a living document that will be regularly updated as it becomes aware of new or other existing initiatives.

2. Methodology

The initiatives presented in this report are drawn from the current EIP membership, previous documentation of the EIP, information from participants at the Annual Meeting and online searches (google and social media). Initiatives were selected on the basis of either, or a combination, of three core functions: peer-to-peer alliance, knowledge hub or community of practice.

109 initiatives were identified and examined. 78 proved still active, 20 appear to be inactive for some time, and 10 showed no sign of recent activity. This reports focuses on the 78 active initiatives.

3. Definitions

Peer-to-Peer learning

The EIP Guide to P2P learning defines P2P learning as involving individuals exchanging knowledge and experience with each other, and diffusing this knowledge back to their organisations to ensure an impact – at scale - on reform initiatives. It entails peer engagement with sustained individual contacts to ensure that the right learning outcomes are achieved.

Knowledge Hub

A knowledge hub is a repository of resources for the purpose of disseminating information, educational resources and tools, to strengthen the capacity of users around a particular area of interest.

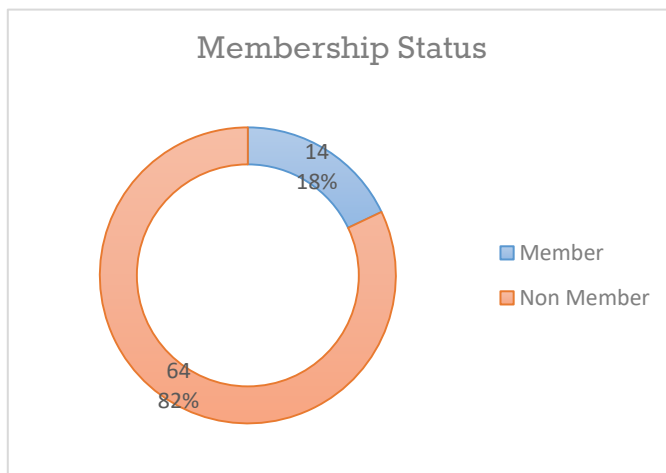
Community of Practice

A community of practice is a group of people who share analysis and experiences on a particular topic, and learn how to do it better as they interact regularly.

It is worth mentioning that none of the above definitions is standardised, and initiatives were identified as P2P, Knowledge hubs and CoPs based on self-identification and how their respective working methods contribute to P2P learning and institutional development.

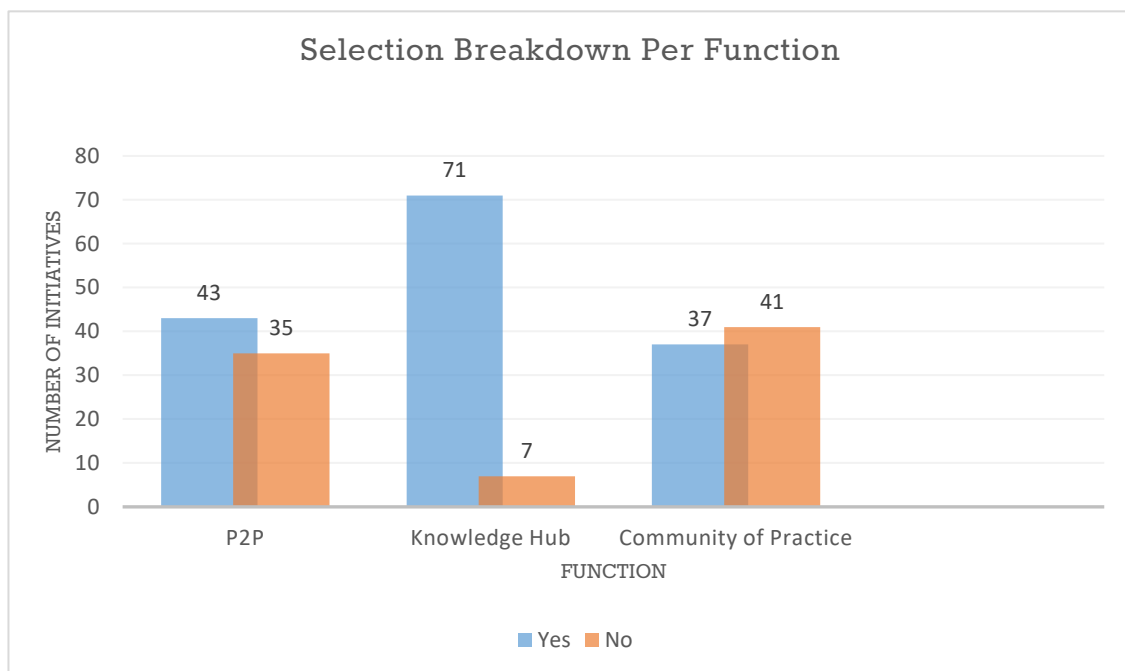
4. Overview of overall selection

Figure 1: Representation of the EIP membership in overall selection



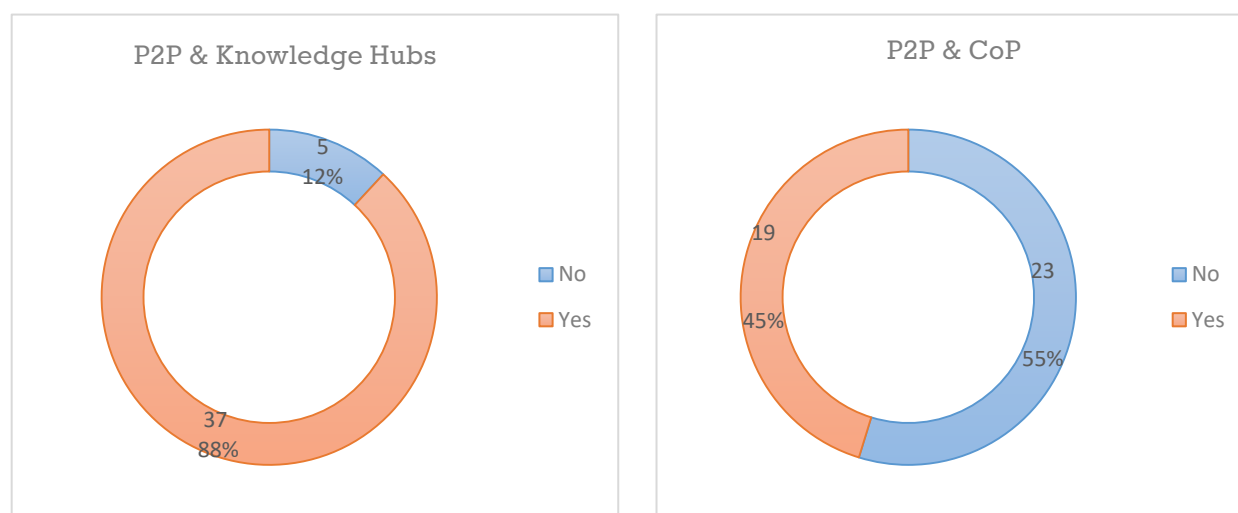
Only 18% of the initiatives are EIP members (AEN, ACBF, ATAF, CABRI, DeLoG, Ibon, etc). The relatively low representation of EIP membership in the mapping suggests that there is strong potential for the platform to grow and establish new partnerships.

Of the 78 active partnerships examined, 42 explicitly stated P2P learning as their core method of work. Almost all (71 out of 78) function as knowledge hubs and 37 as communities of practice. 17 initiatives perform all three functions: P2P learning, knowledge hubs and community of practice.

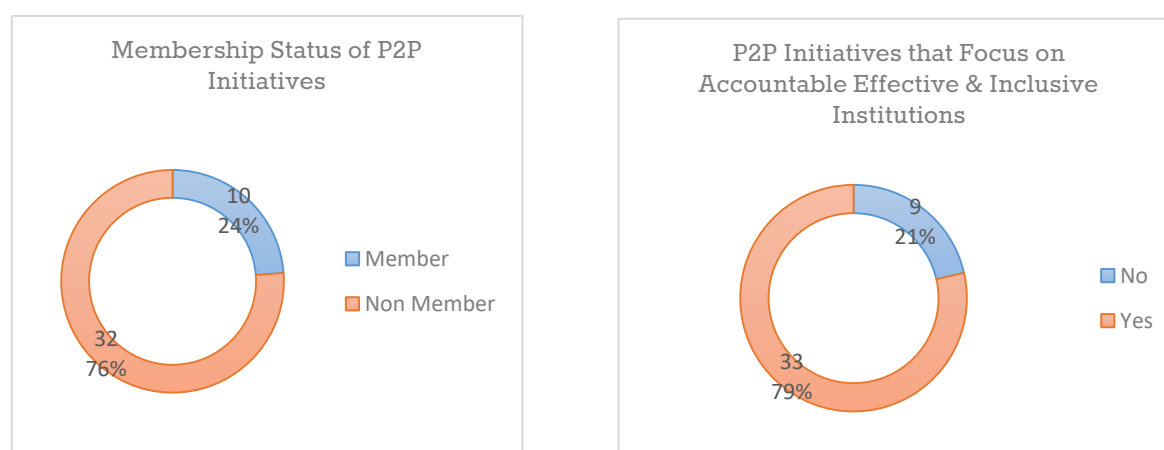
Figure 3: Secondary functions of P2P initiatives



Out of the 42 initiatives that stated P2P learning as their method of work, 37 provide knowledge hub functionalities (e.g. Astana Civil Service Hub, ACBF, CABRI, DeloG, etc.), 19 out of 42 also function as communities of practice (e.g. ATAF, African Peer Review Mechanism, Cities Alliances, etc.) and 17 initiatives combine all three functions (e.g. ATAF, INTOSAI, OGP, PEMPAL, etc.).

5. Focus on Effective Accountable and Inclusive Institutions using P2P

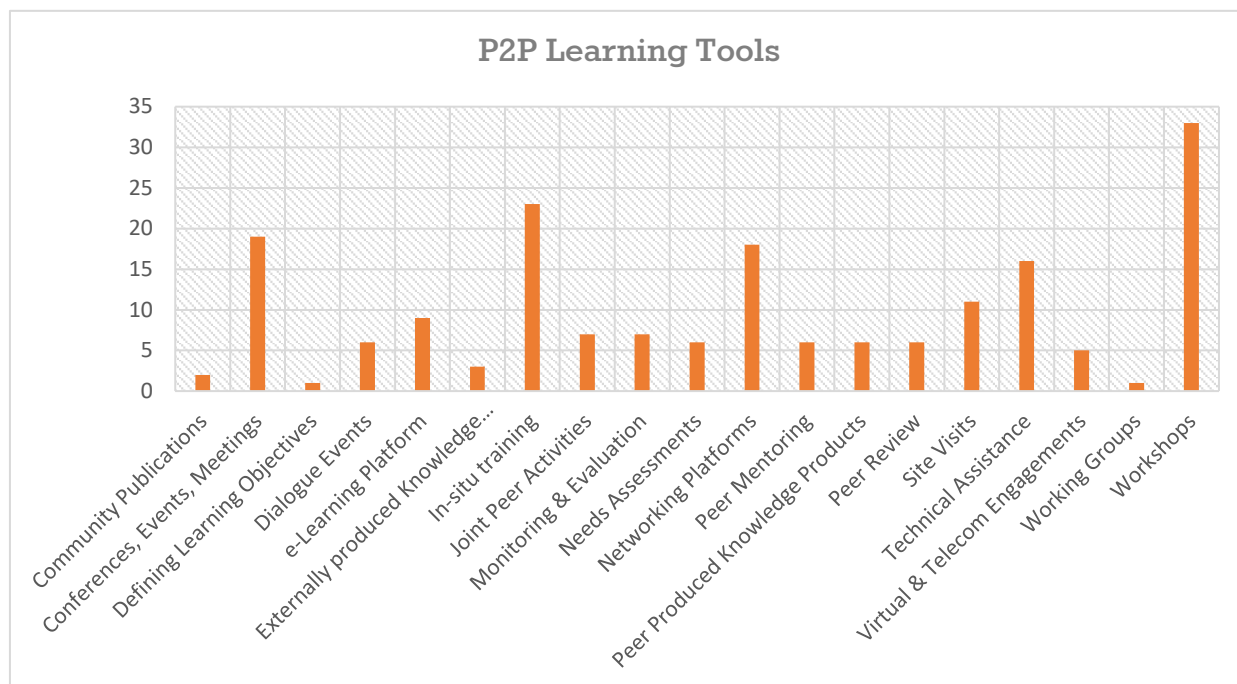
Figure 4: Initiatives with a specific focus on Accountable, Effective and Inclusive Institutions



76% of selection initiatives using P2P learning methodologies are non-members (e.g. Commonwealth Local Government Forum, GIFT - Global Initiative for Fiscal Transparency, Norad Knowledge bank, OGP, etc.), and a significant percentage (79%) of all P2P initiatives focus explicitly on Accountable and Effective Institutions.

5.1. Tools used to facilitate P2P learning

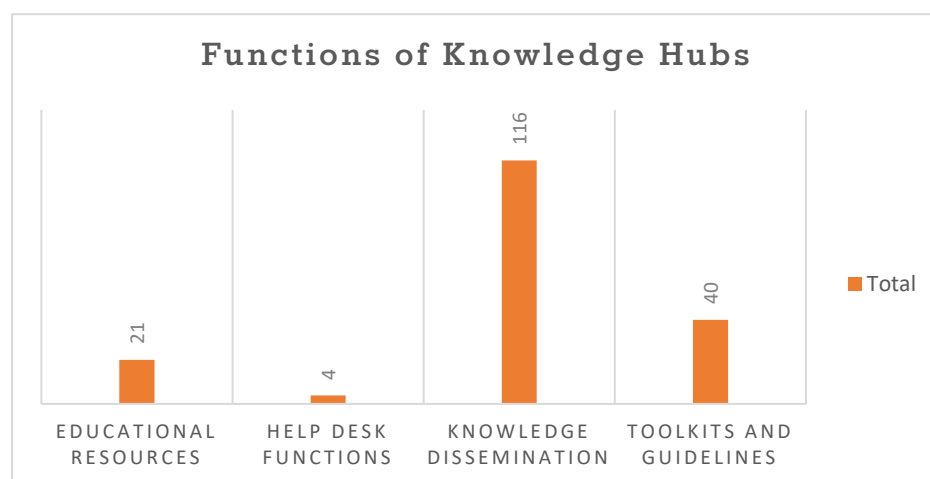
Figure 5: Commonly used tools for P2P Learning



The table above is a categorisation of tools used by P2P initiatives and grouped according to the EIP P2P Learning Guide's categorisation.

Workshops, face-to-face training and networking opportunities followed by meetings and technical assistance are the most used tools employed in peer learning activities. One initiative (Apolitical) operated solely as an online P2P learning and networking platform for public service officials.

Figure 6: Functions of Knowledge Hubs

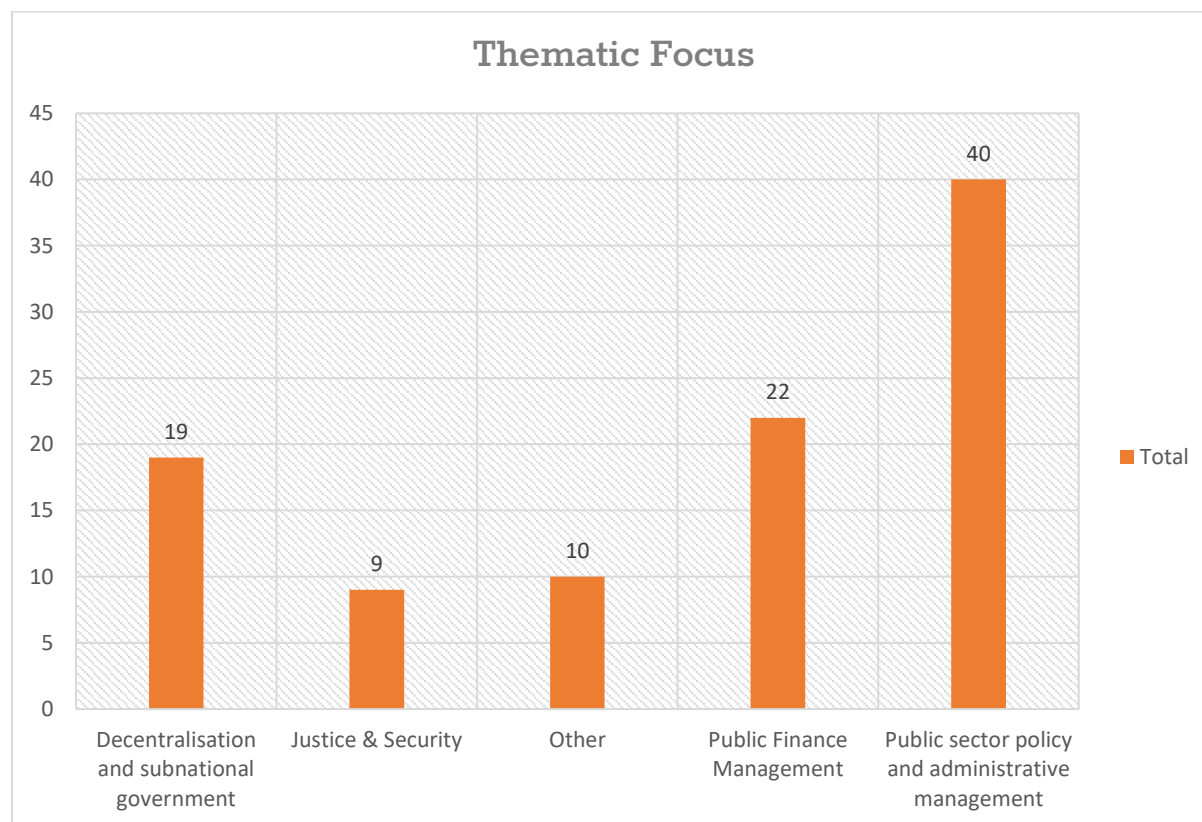


Knowledge dissemination is the predominant feature of P2P initiatives that have a Knowledge hub function, followed by the dissemination of toolkits and guidebooks. Knowledge dissemination mostly consists in sharing policy papers, case studies and good practices. A few initiatives such as the Global Initiative for Fiscal Transparency, LOGIN Asia, Public Expenditure Management Peer Assisted Learning Network or Womenability also focus on equipping users with online educational resources.

5.2. Thematic Foci

Public sector policy and administrative management, public finance management and decentralised governance are the main foci of the selected P2P initiatives.

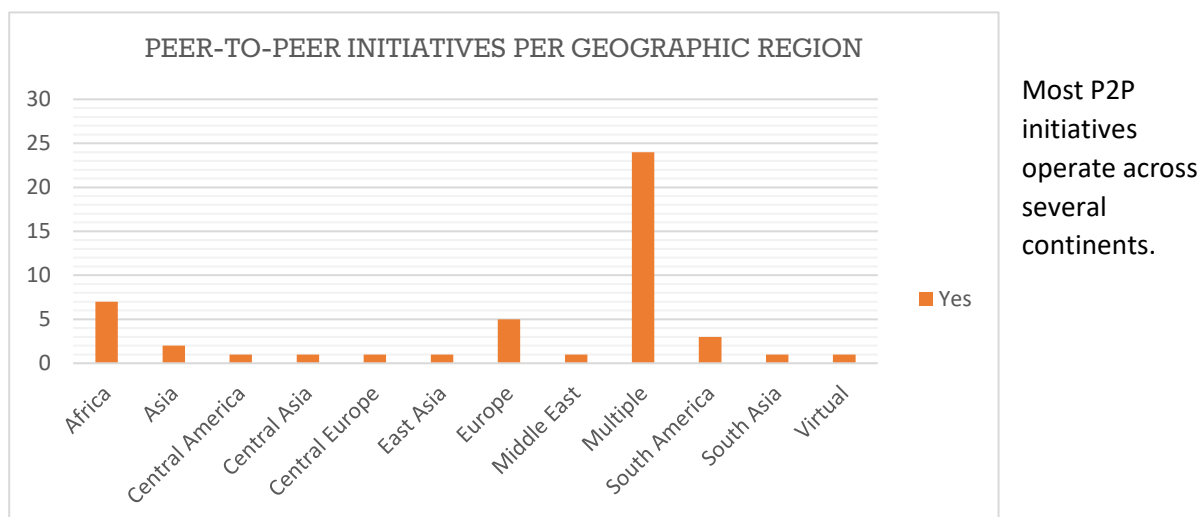
Figure 7: Breakdown of Thematic Foci per Initiative

6. Conclusion

The current mapping indicates that the EIP has ample opportunity to broker new partnerships given the number of identified P2P facilitating organisations that are not yet EIP members. In approaching partnerships, the EIP may have to consider two broad types of partnering strategies, i.) partnerships as a means to re-inforce its institutional effectiveness through increased access to resources, tools and networks, and ii.) partnerships where the EIP directly or indirectly promotes and facilitates peer-to-peer alliances and alternative approaches to public sector reform and institutional development.

The selection criteria of potential partners would hinge on the type of partnership envisaged. In an aim to reinforce its institutional effectiveness, the EIP may consider peers based on the following criteria:

- Experience in facilitating/incubating P2P partnerships
- Use of evidence-based methodologies and tools
- Availability of resources to carry through ambitious or innovative experiments
- Degree of alignment to the EIP strategic vision.
- Breadth of their network

The EIP as a facilitator/incubator of P2P alliances may have to clarify what sectoral and geographical areas it wants to focus on prior to brokering partnerships, in order to focus its limited resources on strategic priorities. Such sectoral areas for consideration may be Domestic Resource Mobilisation, integrity and accountability, etc. and geographical areas might be one or more countries or a region (Africa for example). After such a preliminary scoping of the EIP's focus, the following criteria may be used to identify potential partners:

- Degree of maturity/engagement in the area of P2P learning,
- Extent to which organisations are open to experimentation of new approaches,
- Willingness and ability to commit to medium to long term learning alliances,
- Inclination to use country systems.

Annex 7.1 lists some initiatives which the EIP could consider for mutually beneficial alliances that use P2P methodologies to promote Accountable, Effective and Inclusive Institutions. These are a blend of active initiatives with global, regional and local outreaches, large networks and membership bases, focussing on institutional capacity development in the areas of public finance management, gender equality, democratic participation, innovative finance for sustainable development, local governance, etc. The EIP's role as a global P2P platform and knowledge hub could help create new types of partnerships between institutions that would not otherwise consider pairing-up, in various

configurations (in-country, regional and global alliances), and with multiple stakeholders (donors, partner countries, CSO, etc.).
